## **DIVYANGJAN POLICY**

#### 1. Introduction:

Shirdi Sai Rural Institutes, Arts, Science and Commerce College, Rahata is committed to providing necessary guidance and counseling to differently abled students (Divyangjan). The college ensures a barrier-free environment where individuals with disabilities can move safely and freely and utilize the facilities within the built environment.

#### 2. Objective:

To understand the various rights, regulations, scholarships provisions, facilities, and opportunities provided by legislation to persons with disabilities, ensuring equal opportunities, protection of rights, and full participation.

- To ensure implementation of all legislation regarding persons with disabilities.
- To create a comfortable regulatory mechanism for the effective delivery of services to disabled students and staff in college.
- To foster an inclusive culture to prevent discrimination, exploitation, and exclusion of disabled students and staff from all spheres of work and education.
- To promote respect for human diversity and the legal capacity of persons with disabilities.

#### 3. Policies and Measures:

- The college will ensure admission to as many differently abled students as possible and provide fee concessions, assistance during examinations if required, and other needs pertaining to differently abled persons.
- Assess the educational needs of students and facilitate the procurement of assistive devices for them.
- Facilitate scholarship facilities for eligible students.

#### 4. Infrastructural Facilities:

• The college provides disabled-friendly infrastructure, including ramps and disabled-friendly washrooms.

#### 5. Built Environment with Ramps:

According to the Persons with Disabilities Act 2016, discrimination against disabilities is strictly prohibited. Shirdi Sai Rural Institutes, Arts, Science and Commerce College, intends to provide a comprehensive and inclusive teaching and learning environment to differently abled students and employees. Thus, ramps are built on the campus along with wheelchairs, easily accessible classrooms, computer facilities.

#### 6. Admission Policy for Persons with Disabilities:

According to guidelines provided by Savitribai Phule Pune University, Pune, admission seats are reserved in all programs for persons with disabilities.

#### 7. Exam Policy:

The college shall make suitable arrangements for Divyangjan students to take examinations, following the rules and regulations issued by Savitribai Phule Pune University, Pune. This includes providing extra time and allotting scribes as needed.

#### 8. Compliance
